

## Introduction

Peking Union Medical College Hospital (PUMCH) is a tertiary comprehensive hospital and the national center for diagnosis and treatment of difficult and critical cases, which consecutively topped the "Best Hospital Ranking in China" from 2009 to 2020.



The Department of Obstetrics and Gynecology in PUMCH is the National Diagnostic and Therapeutic Center of OB&GYN Complicated Diseases, also consecutively topping the specialist reputation list of Chinese hospital rankings for 11 years. We have 4 sub-special centers including obstetric center, general gynecology center, gynecology oncology center and reproductive endocrinology center. We possess 343 beds in total, and 143 full-time staff.

For PAG service, our center treats over 4000 out-patient cases per year and performs over 100 minor and major PAG operations per year, accumulating lots of experience in this field. We have specialists in gynecological surgery, endocrinology and oncology for our PAG service. Also, we have strong support group from department of pediatrics, radiology, psychology, orthopedics.

#### **Training Program**

#### A. Objectives

This is a two-year program aims at offering comprehensive training in the clinical practice and research in PAG. Trainees will be familiar with the diagnosis and management of common situation in this area, and will acquire basic knowledge and principles of management in the difficult and complicated situations, such as congenital genital tract malformations, disorders of sex development, gynecological oncology in pediatric and adolescents.

#### **B.** Training Plan

#### Duration: 24 months

Whole training program will be divided into 5 sections:

## 1. Rotation in general gynecology ward for 6 months

This ward mainly admits young patients with genital tract malformations, including MRKH syndrome, HWW syndrome, congenital vaginal atresia, congenital cervical dysplasia etc. Trainees can learn diagnosis, evaluation, operations and treatments of these diseases. Trainees will participate in at least 50 operations on female genital tract malformations.

2. Rotation in gynecological oncology ward for 5 months

This ward admits pediatrics and adolescent patients with malignant and benign gynecological tumors. Main training goal is the standard management process of patients, including operations, chemotherapy, radiotherapy and immunotherapy.

3. Rotation in gynecological endocrinology ward for 5 months

This ward admits young patients with disorders of sex development, including congenital adrenal cortical hyperplasia, androgen resistance syndrome, gonadal dysgenesis. Diagnosis, operations and long-term management can be learned in this ward.

4. Rotation in out-patient clinic of PAG for 6 months

Trainees will rotate our out-patient services of PAG for 6 months (3-4 out-patient sections/week), to learn the management of young patients with complaints related to PAG.

5. Elective parts

Trainees may choose one/two interested departments related to PAG for 2 months, including departments of pediatrics, radiology, nutrition, psychology.

## C. Requirements for trainees

A trainee must complete the residency training in obstetrics and gynecology, and can speak Chinese or English fluently.

During the training program, the trainees will be evaluated by performance at the end of each section. After completion of this program, the trainees will be able to apply for the International Fellowship examination of Pediatric and Adolescent Gynecology, Part I and II.
